To vote in Arkansas you may register:

- In person while acquiring or renewing an Arkansas drivers license, at one of many state agencies designated to register voters, at a voter registration drive, or at the County Clerk's office.
- By mail via application to the office of the Secretary of State; pre-addressed mail-in applications can be picked up at local libraries, many banks, and various organizations such as the League of Women Voters or requested from the Secretary of State by calling 1-800-482-1127 or printed off from the Secretary of State's web site: www.sosweb.state.ar.us

You must register at least thirty days prior to the election (mailed applications must be postmarked by the 30th day prior to the election; applications made at state agencies must be completed by that date). **If you have not received confirmation from your County Clerk within ten days, call the County Clerk's office (479-444-1711) immediately.**

You must be a U.S. citizen, at least 18 years of age before the election (you need not be 18 at the time you register, but must be by the time you vote).

If you move within the same county, notify your County Clerk of your change of address. If you move to a different county, you must register as a new voter in the new county.

You may vote absentee by calling your County Clerk and requesting an application for an absentee ballot. Early voting begins at the County Clerk's office 15 days prior to primary and general elections, 7 days prior to all other elections. The polls are open on election day from 7:30AM UNTIL 7:30PM.

The League of Women Voters is:

- A nonpartisan organization of citizens, both women and men, dedicated to the principles of representative government and individual liberties.
- A grassroots organization whose members are the decision makers.
- Political because it takes action on a wide variety of public issues.
- Nonpartisan because it does not support candidates or parties. It does, however, encourage individual members to work actively for the candidates or the party of their choice and to run for office.
